

Last Will of Johann Heck

The following Will was sent to me by Pamela Kebis in May 2004.

LAST WILL of JOHANN HECK September 3, 1880

Know all men by these presents, that I, **John Heck** of Brighton, in the County of Nicollet and the State of Minnesota, farmer, being in good health and of soand and disposing

mind and memory, do make and publish this my last will and testament, hereby revoking all former wills by me at any time heretofore made.

And as to all my worldly estate, and all the property, real, personal or mixed, of which I shall die siezed and possessed, or to which I shall be entitled at the time of my deceased, I devise, bequeath, and dispose thereof in the manner following to-wit:

First: My will is that all my just debts and funeral expenses shall by my executor hereinafter named, be paid out of my estate as soon after my decease as shall by him be foand convenient, or as is required by law.

I give, devise and bequeath to my beloved wife **Susannah Heck**, if she shall survive me, all of my property real and personal of which I may die siezed or possessed, to have and to hold the same to her for and during the term of her natural life, meaning hereby to give her the use, possession rents and profits thereof for said term of her natural life, but not to vest any absolute title therein.

Second: After the death of my beloved wife, if she should survive me, I give and bequeath to my son **Joseph Heck**, by my second wife, out of my estate two handred dollars in money to be paid to him by my executor hereinafter appointed within six months after my decease, if my wife should first die, for the sole use of said **Joseph**, his executors administrators or assigns.

Third: I give and bequeath to my daughters **Lucy Heck** and **Anna Heck** out of my estate the sum of two handred dollars in money cash, to be paid to each of them by my executor hereinafter appointed within six months after my decease, if

my wife should first die, for the sole use of said **Lucy** and **Anna**, their executors, administrators or assigns. Item- if my wife survives me then the aforesaid bequests amounting to the sum of six handred dollars are to be paid within six months after the decease of my said wife, and said bequests are to become a specific lien upon any and all property of which I may die seized or possessed of. All the rest and residue of my real personal and mixed of which I shall die siezed and possessed, or to which I shall be entitled at my decease I give, devise and bequeath to be equally divided between and among my stepson **Philip Zern** and my son **Andrew Heck**.

And lastly I do nominate and appoint **Jacob Farmer** of Saint Peter, Nicollet County, Minnesota to be the executor of this my last will and testament.

In testimony whereof, I the said John Heck have to this my last will and testament contained on one sheet of paper, subscribed my name and affixed my seal this the third day of September A.D. 1880.

Johann Heck was the first of our Heck family to immigrate to America in 1852. Johann had five children by his first marriage. The children were Peter, Anna Lucia, Henry (my great grandfather), Joseph and Clara. Following the death of his first wife, Anna Barbara Schaefer in 1855, Johann married the widow, Susannah Sebenbrunner Zeren in 1856. By his second marriage to Susannah he had four more children. The children from the second marriage were Lucy, Joseph Joshiah. Andrew and Annie.

It is interesting to note that none of his children from his first marriage were even mentioned in his will. Philip Zern (sic) mentioned in the will was the son of Susannah by her first marriage.

Johann Heck died June 22, 1885 in Minnesota.

1740 Dental Care

Ever wonder what our ancestors used for dental care? Probably not. I found this article in one of my genealogy newsletters and thought that you might enjoy it.

Use a good tooth powder once a week or once every two weeks for unclean teeth. But the mouth should be rinsed daily after eating with fresh water and scoured with the finger. The tooth powder should not be composed of all rough or all sharp things such as tobacco ashes, powdered coral, pumice stone or brick but should also contain smooth things such as prepared oyster shell, chalk made from mussels, with a lot of seasoning and flavoring.

Another article from 1740 recommends burned hartshorn, powdered oyster shell and white tartar. Also a mouthwash of sal ammoniac and water can be used. Another uses cream of tartar, gum myrrh and oil of cloves. And if all this good dental care fails, you may get a set of artificial ones made from the tusks of the hippopotamus, or sea horse, or from the teeth of some domestic animals. Teeth made of ivory or bone soon become discolored and begin to decay and render the breath offensive.

Comment: maybe the "good old days" were not as good as we sometimes imagined.



What Ever Happened to the Johann Wilhelm Henningfeld Children?

In 1845, the Henningfeld families began moving from Vinnum, Germany to the Waterford, Wisconsin area. Some came in 1845 and some in 1847. The families included Johann Wilhelm and his brothers and sisters, Franz (my great great grandfather), Catharina Elizabeth, Theodor, Dorothea, and Francesca.

In 1847, Johann Wilhelm Henningfeld, known as William in America, along with his wife Catherine Elizabeth Bruggerman and their five children immigrated to Waterford, Wisconsin. The five children were Henry 14, Maria Elisabeth 11, William 7, Carle 4, and Frederick William 9 months.

Tragedy struck the family when Johann Wilhelm Henningfeld died on January 13, 1849, at Waterford. His wife, Elizabeth was pregnant at the time with their sixth child, Catherine Wilhelmine Henningfeld. The child, known as Mina, was born on April 6, 1849. Elizabeth married John Herman Albert later that year on December 16, 1849. The new family lived in the town of Norway, in Racine County, Wisconsin according to the 1850 U.S. Census.

In June 1850, Elizabeth became pregnant with a son, John Henry Albert. John Henry Albert was born on February 28, 1851, however Elizabeth died during childbirth on that same day. The child, John Henry Albert, died four and a half months later.

The question is; Whatever happened to the surviving children? A search of the 1860 census for Wisconsin failed to locate the children. I suspect that the census recorder probably listed the children ander the last name of the family that took the children in.

Most of the children can be accounted for in later years.

Mary Elisabeth Henningfeld married Frederick William Ebbing on November 25, 1852. She died on December 23, 1916, at Wheatland, Kenosha County, Wisconsin.

Henry Henningfeld married Christina Hallen on February 2, 1861 at Waterford. He died on May 30, 1918, at Phillips, Wisconsin.

William Henningfeld was listed as a surviving heir of his parent's estate on September 1, 1917, in Racine County, Wisconsin. Nothing more of him is known.

Carle Henningfeld was also listed in his parent's estate. His name was shown as Charles. Nothing more of him is known.

Frederick W. Henningfeld served during the Civil War in Company "A" of the 43rd Infantry Regiment. Following the war he married Anna Boedding on February 20, 1879, at Saint Louis, Missouri. He died in Saint Louis on January 25, 1918.

The last child, Mina, married Henry Rothering on November 27, 1865, at Burlington, Racine

County, Wisconsin. She was 16 years old when she married. She died November 7, 1869, at the age of 20 years at Burlington.

Several questions still remain about the Henningfeld family. Where did the children live following the death of their mother in 1851? Did they live with the Ebbing family? What ever happened to the children William and Carle?

This is the fun part of genealogy. I'll keep searching through the records and archives and hopefully will find an answer to some or all of these questions.

Heck Family Extended

The following document was found while researching a German web site. The source of the information is Herr Klaus Ring, Ahrmuhlenweg 6, Blankenheim-Waldorf 53945, Waldorf, Germany. Klaus conducted some research for me at the Archives in Germany. We corresponded with each other and I gave him the list of descendants of the Alendorf Heck family. His e-mail address is: salentinernst@freenet.de.

The first person shown, Heinrich Heck, was my great grandfather. He was the third child of the family. Note that the dates are shown as day, month, year which is the European standard. The * means birth date and the + means death date. A letter N following a name means that the surname was unknown.

The significance of this research is that it has references to the documents and that it adds as many as two generations to our research. Some of the records go back to the mid 1600's. Also the villages of origin were named for most of the people. Godparents and witnesses were also named.



In the name, &c. We, Edward, eldest son of the noble King of England, make our Will the Saturday next after Pentecost, in the year of our Lord 1272. First, we bequeath our soul to God, to our Lady, and to all the Saints; and our body to be buried where our executors, that is to say, Sir John de Bretagne, Sir William de Valence, Sir Roger de Clifford, Sir Payse de Chautros, Sir Robert de Tiletot, Sir Otes de Graundison, Robert Burnett, and Anthony Bek, shall appoint: who are also to hold the profits of all our lands in England, Ireland, and Gascony, until our children become of age. And if it should so happen (which God forbid!) that our Lord the King, our father, die whilst our children be under age, we will that the realm of England, and all other lands which should descend to our children, remain in the hands of our executors before named.

and also in those of our dear father the Archbishop of York, and Sir Rog. and other great men of the kingdom, until they become of full age. And for the dowry of our dear wife Eleanor, &c. In testimony of which we have placed our seal to this Will, having requested John Archbishop of Sur, and Vicar of the Holy Church of Jerusalem, and the honorable fathers, Frere Hugh Revel, Master of the Hospital, and Frere Thomas Brerard, Master of the Temple, likewise to place their seals in witness hereof. Dated at Acre, the Saturday before named, the 18th June, in the year of the reign of the King our Father the 55th.
